2 **R277-439. Block Grant Funding for Prevention Programs in Public Education.**

3 **R277-439-1. Authority and Purpose.**

4 (1) This rule is authorized by:

5 _____ (a) Utah Constitution Article X, Section 3, which vests general control and
6 supervision over public education in the Board; and

7 _____ (b) Subsection 53E-3-401(4), which allows the Board to adopt rules in
8 accordance with its responsibilities; and

9 _____ (c) Subsection 53F-2-525(3), which establishes the prevention block grant and
10 directs the Board to make rules to govern the application process.

11 _____ (2) The purpose of this rule is to provide:

12 _____ (a) procedures for an LEA to apply for the Prevention Block Grant; and

13 _____ (b) annual reporting guidelines.

15 **R277-439-2. Definitions.**

16 _____ (1) “Comprehensive prevention plan” means the same as the term is defined in
17 Subsection 53F-2-525(1).

18 _____ (2) “Participating LEA” means an LEA that:

19 _____ (a) applies to participate in the prevention block program described in Section
20 53F-2-525 and this Rule; and

21 _____ (b) is approved by the Superintendent to participate in the prevention block grant
22 program.

25 **R277-439 -3 Application Process**

26 _____ (1) The Superintendent shall develop an application for an LEA that is interested
27 in applying for prevention block grant funds.

28 _____ (2) An LEA may apply for the grant in a form and within the deadlines specified
29 by the Superintendent.

30 (3) The Superintendent shall distribute prevention block grant funds to a
31 participating LEA based on funds available from the substance abuse prevention
32 account and through the underage drinking and substance abuse prevention program
33 restricted account as described in Section 53F-2-525 and Section 53F-9-304.

34 ~~[(4) If excess funds remain in the restricted account at the end of a given fiscal~~
35 ~~year after the use described in Subsection (5)(a), the Superintendent may distribute the~~
36 ~~excess funds to participating LEAs in the subsequent fiscal year through the block grant~~
37 ~~funding for public education prevention programs as described in Section 53F-2-525.]~~

38 (5) An LEA's application for the prevention block grant shall include the
39 following:

40 (a) the LEA's approach and rationale underlying the comprehensive prevention
41 plan;

42 (b) a demonstration of the LEA's specific prevention needs;

43 (c) data that support the substance and cost of the LEA's comprehensive
44 prevention plan;

45 (d) the use of funds to implement the LEA's comprehensive prevention plan; and

46 (e) specific outcomes that will be used to measure the success of the plan.

47 (6) The Superintendent shall provide:

48 (a) guidance to LEAs about designing and implementing the comprehensive
49 prevention plan;

50 (b) technical assistance to LEAs with prevention needs; and

51 (c) targeted professional learning opportunities in evidence-based prevention
52 practices.

54 **R277-439-4 Allowable expenses**

55 (1) Awarded funds may be used for the following purposes:

56 (a) Implementation of the comprehensive prevention plan;

57 (b) Prevention-focused parent seminars as described in Subsection 53G-9-
58 703(2);

- 59 (c) To supplement specific prevention needs identified by the LEA that can be
60 justified through data;
61 (d) Prevention science professional learning;
62 (e) Supplies and materials related to implementing prevention programs; and
63 (f) Other evidence-based prevention practices authorized by USBE.
64 (2) An LEA may not use funds received through this program for:
65 (a) food;
66 (b) capital improvements;
67 (c) metal detectors; and
68 (d) vape detectors.

70 **R277-7- 439- 5 Annual Reporting Requirements**

71 (1) A participating LEA that receives prevention block grant funds shall provide
72 the Superintendent with a year-end report in a form and within the deadlines specified
73 by the Superintendent.

74 (2) The Superintendent may require additional evaluation or audit procedures
75 from an LEA to demonstrate the use of funds consistent with the law and Board rules.
