Superintendent Coleman voiced his concern that the amount of work they are suggesting is not necessary for the school's needs. He recommended having a third-party assessment. He will be meeting with the State Building Board to request their support for purchasing the building.

USDB Financial Report

USDB Finance Director Letty Debenham gave the monthly financial report. She introduced new hires in the USDB Finance Division, Jessica Hardy and Victoria Summers. She also reported that a Purchasing Agent has been hired that will start on December 14.
