Senator Millner was welcomed to the meeting. She discussed S.B. 67 Partnerships for Student Success, S.B. 78 State Board of Education Candidate Selection, and S.B. 51 Teacher Leader Role. She received questions and input from Board members.

Discussion with Representation Kraig Powell

Representative Powell was welcomed to the meeting. He discussed H.B. 164

Educational Testing Amendments, H.B. 92 Local School Board Levy Rate Amendments, and H.B.

193 Charter School Property Tax Amendments. He received questions and input from Board members.

School Resource Officer Request

William Matthews, Director of Dixie State University Computer Crime Institute, was welcomed to the meeting. He distributed information about a legislative funding request for the Institute that was presented to the Public Education Appropriations Subcommittee today. It is a request to fund training by the Institute for school resource officers and administrators.

Representative Kennedy was also welcomed to the meeting. He asked for Board input on the funding request.

Member Warner questioned why the funding would be coming out of the Education Fund, and suggested it should be funded by law enforcement.

Motion failed, with Members Castle, Cummins, Crandall, Hansen, Huntsman, Johnson, and Thomas in favor, and Member Warner opposed.

MOTION was made by Member Cummins and seconded by Member Hansen that the Board support H.B. 164 *Educational Testing Amendments*.

Motion carried unanimously.
