## **Beverley Taylor Sorenson Foundation Grant**

Cathy Jensen, USBE Fine Arts Specialist, and Lisa Cluff, Director for Art Works for Kids, were welcomed to the meeting. Ms. Jensen reported that the Beverley Taylor Sorenson Foundation contacted her last week and invited the State Board of Education to make

application for an additional grant from the foundation for up to \$110,000. The grant would be a flow through to local education agencies to support arts specialists, or the Beverley Taylor Sorenson Arts Learning Program and its university partners. It was clarified that the bulk would be used to hire arts specialists for schools. The grant needs to be awarded before the end of the calendar year.

Deputy Superintendent Jones noted that if the application is approved and signed today, a notice of the grant would still need to go to the Appropriations Committee of the Legislature.

**MOTION** was made by Member Cannon and seconded by Member Belnap that the Board approve acceptance of the \$110,000 grant, as presented, from the Beverley Taylor Sorenson Foundation.
