Overview of Fiscal Note Process

Deputy Superintendent Scott Jones introduced Ben Leishman and Jill Curry from the Legislative Fiscal Analyst's Office. They reviewed the process by which fiscal notes on legislative bills are developed.

Legislation

Senator Lincoln Fillmore discussed S.B. 240, Local School Options. He indicated the bill represents a large amount of local control in schools and would give local school boards and school community councils the ability to craft their own programs. It is initially for a pilot. Board members provided feedback on the bill. He indicated the intent is not for the bill to pass this session, but to launch the concept, and hopefully, to come back in the interim session for more discussion.

Tiffany Stanley, USBE Policy Analyst, reviewed H.B. 291, School and Institutional Trust Lands Amendments.

MOTION was made by Member Hansen and seconded by Member Graviet that the Board oppose H.B. 291.

Motion carried, with Member Cannon opposed.

Deputy Superintendent Angie Stallings reviewed S.B. 223, Modifications to Charter School Governance, H.B. 231, Educator Evaluation Amendments, and H.B. 413, Public School Membership in Associations.

MOTION was made by Member Hansen and seconded by Member Warner that the Board support H.B. 231.

Motion carried unanimously.

Tiffany Stanley reviewed S.B. 220, Student Assessment and School Accountability Amendments.

MOTION was made by Member B. Cummins and seconded by Member Boulter that the Board direct staff to request that the sponsor of S.B. 220 consider changing line 584 to read: "a college readiness assessment accepted by universities."

Motion carried unanimously.

MOTION was made by Member B. Cummins and seconded by Member Riebe that the Board direct staff to ask the sponsor of S.B. 220 to consider looking at school grading in a way that may reduce the impact of A to F, and possibly remove the A to F designations.

Motion carried; Member Wright absent.

Adjournment

MOTION was made by Member L. Cummins and seconded by Member Neilson that the meeting adjourn.
