Overview of School Accountability

Assistant Superintendent Darin Nielsen presented an overview of the Utah School Accountability System. [For more details, see General Exhibit No. 19-28.]

Review of Legislation

Representative Marie Poulsen was welcomed to the meeting. Representative Poulsen reviewed H.B. 199 Education Accountability Amendments, designed to remove the requirement for the State Board to assign letter grades to schools. Board members expressed support and thanked her for her work on the bill.

Representative Suzanne Harrison was welcomed to the meeting. She reviewed her bill, H.B. 208 Safe Routes to School Program. The bill would provide funding and support for the

safety of students going to and from school. She clarified that the funding would come from the General Fund and codifies a program that already exists.

Deputy Superintendent Stallings reviewed H.J.R. 13 Proposal to Amend Utah

Constitution, which amends Article X, Section 3 [State Board of Education] to remove the word

"elected."

USBE Policy Advisor Jeff Van Hulten reviewed H.B. 120 Student and School Safety Assessment which enacts provisions related to school safety.

Legislation/Budget Priorities

MOTION was made by Member Lear and seconded that the Board oppose H.J.R. 13 Proposal to Amend Utah Constitution—State Board of Education.

Several members voiced that they would prefer to see the bill that will accompany the resolution prior to voting concerning the legislation.

Member Lear spoke to her motion, stating that she cannot support anything that removes "election" from the Constitution in terms of the State Board of Education, and she feels it is a protection provided by the Constitution.

Motion carried 8-4, with Members Boulter, Cannon, L. Cummins, Earl, Ellis, Graviet, Lear and S. Hansen in favor, and Members Belnap, B. Cummins, Davis, and L. Hansen opposed.

MOTION was made by Member Lear and seconded that the Board support H.B. 208 Safe Routes to School Program.

Member Lear spoke to her motion, indicating this would be a great use of a minimal amount of money.

Several Members expressed concerns that more information is needed about the funding, that state funds would be used for a local or parental issue, and that it codifies a program that already provides grants.

Other Members expressed support as this would facilitate an otherwise very long process to get funding for things such as sidewalks that provide greater safety for children, and would have health benefits as well.

Motion to amend was made by Member Belnap and seconded that the Board support the concept of safe routes to school rather than the bill.

Motion to amend failed, with Members Belnap, Boulter, L. Cummins, Earl and Ellis in favor, and Members Cannon, B. Cummins, Davis, Graviet, L. Hansen and S. Hansen opposed.

Motion failed 6-5, with Members Cannon, B. Cummins, Davis, Graviet, L. Hansen and S. Hansen in favor, and Members Belnap, Boulter, L. Cummins, Earl and Ellis opposed.

Adjournment

MOTION was made by Member Lear and seconded that the meeting adjourn. Motion carried. The meeting adjourned at 1:39 p.m.
