# **Opening Business**

Vice Chair Brittney Cummins called the meeting to order at 12:02 p.m.

### **Review of Legislation**

# Legislator Review of Bills

Representative Steve Eliason discussed a bill that is currently being drafted to provide in-school mental health screening for students. He informed that it would be a mandatory statewide requirement with an opt-out provision for local education agencies. The screening itself would be an opt-in by parents. The intent is to work with mental health agencies to provide the information from the screening to parents with options for help within communities. Representative Eliason confirmed that the funding would come from the Education Fund.

Board members shared concerns, chiefly on the burden on school personnel and student privacy.

# Legislative Policy Requests

Angie Stallings, Deputy Superintendent, and Jeff Van Hulten, USBE Policy Analyst, presented Legislative Proposal No. 1, to seek legislation to insert statutory language codifying state program monitoring standards into Utah Code, with the proposed language: "Unless otherwise specified in Utah Code, the board shall use federal monitoring standards when the board monitors state program."

**MOTION** was made by Member Belnap and seconded that the Board add Legislative Proposal No. 1 to the Board list for statutory changes and add to the wording in the proposed language: "or Board rule" after "Utah Code."

Motion carried unanimously.

### Action on Budget/Legislation

# Base Budget Bill

Scott Jones, Deputy Superintendent, presented information about the base budget bill along with a comparison between the FY2020 budget and the proposed FY2021 budget.

Superintendent Jones will keep the Board appraised as changes arise.

# **USBE FY2021 Budget Priorities**

Deputy Superintendent Jones and Dale Frost, USBE Fiscal Policy Analyst, reviewed the Board's FY2021 budget request documents. Superintendent Jones indicated that a change will be made to add more funding for the Statewide Online Education Program.

### 2020 General Session Legislation

Deputy Superintendent Stallings and Jeff Van Hulten reviewed the following bills:

H.J.R. 13 Proposal to Amend Utah Constitution-State; H.B. 99 Enhanced Kindergarten

Amendments; H.B. 114 Early Learning Training and Assessment; H.B. 58 Electronic Cigarettes in Schools Amendment; H.B. 14 School Absenteeism and Truancy Amendments; and H.B. 16 School Meals Program Amendments.

# Board Positions on Legislation

**MOTION** was made by Member Lear and seconded that the Board support H.B. 16 School Meals Program Amendments.

Motion carried, with Members Belnap, Cannon, Cummins, Graviet, Hansen, Haynes, Lear and Marsh in favor, Member Earl opposed, and Member Davis abstaining; Member Newell absent.
