### **Opening Business**

## **Budget Priorities**

### 2022 Legislative Session Funding Priorities

Sam Urie, School Finance Director, and Jeff Van Hulten, Policy Advisor, reviewed the Board's process to identify its budget priorities for the 2022 Legislative Session. Jeff Van Hulten presented an update about the bills related to the Board's funding priorities.

### **Wavier Request to Rule R277-477**

Paula Plant, School Children's Trust Director, explained the request for the waiver request. R277-477 requires schools to submit School LAND Trust final reports to be reviewed by the school's LEA, followed by a summary report to the governing Board. USBE has been rolling out a new website, and the required form was delayed. The report form should have been posted by January 15, 2022, but wasn't available to schools until February 3, 2022. As a result, schools and LEAs have requested additional time to meet their obligations. The delay is complicated for medium to large LEAs to review their reports quickly. Staff recommends extending the March 1 deadline to March 18 to match the delay caused by the website rollout.

**MOTION** was made by Member Boothe and seconded by Member Norton that the Board extends the deadlines in Subsections R277-477-6(7) and (8) from March 1 to March 18 for the 2021-22 school year.
