Board Member Message

Board Member James Moss shared a welcome message.

Education Highlight

Ryan Bartlett, Director of Strategic Communications, highlighted the four Utah Students Named 2022 U.S. Presidential Scholars:

Public Comment for USBE

Susie Estrada spoke about the hard work of the out-of-school-time professionals and the funding that is needed for their services.

Deanna Holland, a parent of school-aged children in Northern Utah, stated that the Board does not listen to parents' concerns but rather the influence of teacher's unions. She shared her worries about schoolbooks that are pornographic in nature.

Heidi Matthew, President of the Utah Education Association (UEA), spoke for the last time as the current president. She thanked the board members for their service and support for all they do for Utah education.

Briawna Hugh, teacher, and parent in Alpine School District spoke about what is like to be in Utah junior high schools.

Jen Brown, President of the Utah Citizens for the Constitution, spoke about the importance of school civic standards.

Aaron Bullen, located in Alpine School District, stated legislative and state board timeframes about the issue of inappropriate books in libraries. He is unsupportive of books, such as "Red Hood" by Elana K. Arnold, that are more appropriate for adults rather than teens.

Gayle Ruzicka spoke for Utah Eagle Forum about not supporting Utah's Portrait of a Graduate proposed Resolution.

Lisa Bruhn, a national expert on the sinister agenda behind social-emotional learning, spoke about not supporting Utah's Portrait of a Graduate proposed Resolution.

Garrett Smith, spoke about the Utah Code 53G-10-204. Civic and character education and how the guidelines should be implemented by USBE into education standards and curriculums.

Tad Callister, a concerned citizen, spoke about his love for the Constitution and spoke about the Utah Code 53G-10-204. Civic and character education. (2)(c)the cultivation of a continuing understanding and appreciation of a constitutional republic and principles of representative democracy in Utah and the United States among succeeding generations of educated and responsible citizens is important to the nation and state.

Jonas Rodriguez, Vice-president of the Benjamin Franklin Center of Constitutional Studies, spoke about the Utah Code 53G-10-304. Instruction on the flag of the United States of America. He recommended that children should be taught the significance of the United States flag.

Do The Write Thing (DtWT)

The Do the Write Thing Challenge offers 7th and 8th-grade students an opportunity to examine the impact of youth violence on their lives and to communicate in writing what they think should be done to prevent this type of violence. The Challenge emphasizes personal responsibility by encouraging students to make a commitment to take positive steps to change the problem. Ultimately, the program strives to help students break the cycle of violence in their homes, schools and neighborhoods.

Monthly Budget Report

Scott Jones, Deputy Superintendent of Operations, and Deborah Jacobson, Assistant Superintendent of Operations, presented the Board of education's monthly budget report. In accordance with the Money Management Act and the Budgetary Procedures Act, the Utah State Board of Education is provided a report on the status of funds for their internal budgets.

<u>Discretionary Funds Report</u>

Scott Jones, Deputy Superintendent of Operations, and Deborah Jacobson, Assistant Superintendent of Operations, presented the Board of education discretionary fund report. Per the Money Management Act and the Budgetary Procedures Act the Utah State Board of Education is provided with a status of the funds. Deborah Jacobson, Assistant Superintendent, updated the Board on the FY2021 P-12 Discretionary Funds account.

Federal COVID-19 Relief Funding Update

This presentation provided an update on the status of federal COVID-19 relief funding to support Utah K-12 schools and communities. The update will include the status of reimbursements to the field and a report on existing COVID-19 relief funding state projects. The USBE staff who presented were Sara Harward, CARES Educational Specialist (Coronavirus Aid, Relief, and Economic Security), Max Lang, Coordinator, and Sarah Young, Chief of Staff.

Angie Stallings, USBE Deputy Superintendent of Policy and Scott Jones, Deputy Superintendent of Operations presented the preparation agenda items.

The Finance Committee discussed potential requests for business cases during the Committee's May Committee meeting. The purpose of this agenda item is for Board members to provide feedback on whether the business cases requested by the Committee should continue for further Board consideration in a future meeting. Board Chair's Report

Chair Huntsman reflected on celebrating the 2021-22 school year. He recognized that Utah has many wonderful school traditions for the end of the school year. One of his favorites is Field Day at Midway Elementary School. He highlighted the fifth grade because they are the final grade in the elementary school and are in charge of hosting this end-of-the-year event. They are leaders in the school, and they make sure everyone is safe and having fun.

He followed up with the commonality of all the Utah students, from kindergarten to the seniors, who are all completers and become completers of their adult life – thanks to everyone involved in education.

Board Resolution

Support of the USBE Portrait of a Graduate

The following board members spoke about their resolution request to support the Portrait of a Graduate; Scott Hansen, Stacey Hutchings, Carol Lear, Brent Strate, and Cindy Davis.

Today's youth will face a world that looks dramatically different than that of their parents. To succeed, they will need to develop skills and expertise in alignment with Utah's Portrait of a Graduate. With this end goal in mind, USBE led an extensive stakeholder engagement process in 2018 and 2019 to identify the ideal characteristics of a Utah high school graduate. USBE held 40 stakeholder input sessions, including four public meetings across the state, and gathered public, parental, and professional input. Additionally, the agency released a draft for a digital public comment period in spring 2019. These efforts led to the creation of the USBE's Portrait of a Graduate, called the Utah Talent MAP. MAP stands for:

- Mastery is the ability to demonstrate depth of knowledge and skill proficiency.
- Autonomy is having the self-confidence and motivation to think and act independently.
- Purpose guides life decisions, influences behavior, shapes goals, offers a sense of direction, and creates meaning.

The Utah Portrait of a Graduate, described above, identifies 13 elements that begin at home and are cultivated in educational settings: academic mastery; wellness; civic, financial, and economic literacy; digital literacy; communication; critical thinking and problem solving; creativity and innovation; collaboration and teamwork; honesty, integrity, and responsibility; hard work and resilience; lifelong learning and personal growth; service; and respect. USBE further developed this vision for graduates through the design of competencies for pre-kindergarten through postsecondary education in September 2020, and model rubrics in summer 2021.

The Portrait of a Graduate serves as our north star for system transformation. As school districts and charter schools develop Portraits of a Graduate for their unique communities, we continue working through the implications of this vision for the design of our system at the

state level. Our aim is to create the conditions for school systems throughout the state to intentionally deliver on this powerful vision for all students to be able to "succeed and lead".

MOTION was made by Member Hansen and seconded by Member Strate that the Board approves the Resolution to support the Portrait of Graduate.

UTAH STATE BOARD OF EDUCATION RESOLUTION NO. 2022-02

RESOLUTION IN SUPPORT OF UTAH'S PORTRAIT OF A GRADUATE

"What are the hopes, aspirations, and dreams that our community has for young people?"

"What skills and mindsets do young people need to ensure opportunities for their future?"

These questions were the driving force behind the creation of Utah's Portrait of a Graduate.

The process began with the assembly of a task force including Utah Board of Education
("USBE") members and USBE staff. The group collected input from a wide array of
stakeholders, including recent graduates, students, parents, educators, business leaders,
and community members, and over the course of nearly two years, distilled the
information gathered into the Utah Talent MAP, commonly referred to as Utah's Portrait
of a Graduate ("PoG"). The PoG is Utah's vision for Utah high school graduates. It was
developed in Utah, by concerned Utahns, to benefit Utah's children.

Utah's PoG has gained national and international critical acclaim and has been widely accepted by Utah schools. It has served to focus the efforts of education stakeholders on helping graduates not only develop academically, but also learn life skills that will prepare them to "succeed and lead by having the knowledge and skills to learn, engage civically, and lead meaningful lives."

Recent attacks on public education have extended to Utah's Portrait of a Graduate, claiming

- that it was somehow imposed on the USBE by outside groups. Nothing could be further from the truth. The Utah State Board of Education cannot remain silent amidst these attempts to undermine one of the keystones of our educational efforts. Recognizing the great value of the work put into the development of Utah's PoG and the importance of continuing to use it as a foundation for future action, we state and resolve as follows:
- WHEREAS Utah's youth face a world of ever-increasing challenges; to succeed, they will benefit from a roadmap that provides intentional learning opportunities for academic and behavioral achievements; and
- WHEREAS the PoG encourages local school districts and schools to develop their own portraits of a graduate by involving local academic experts, parents, and community members to identify community values and priorities for students; and
- WHEREAS many Utah school districts, schools, policymakers, and legislators rely on the PoG to focus budget priorities, teacher training, and curriculum decisions, both locally and statewide; and
- WHEREAS the characteristics identified in the PoG provide a healthy balance of academic, personal, and interpersonal skills and immediate and aspirational goals to focus student learning; and
- WHEREAS it is the stated objective of the PoG to support parents' primary efforts to educate and nurture their children at home by cultivating ideal characteristics through school and extracurricular activities and opportunities;
- NOW, THEREFORE, BE IT RESOLVED that the Utah State Board of Education emphatically asserts that the PoG is exactly what it claims to be, a vision for future generations of Utah graduates who will successfully carry this great state to a future full of hope and opportunity; and reaffirms its enthusiastic support for the process by which the Utah PoG was developed, the value of the characteristics it identifies, and the work of the USBE and all Utah educators to continue to use the PoG as the foundation of our efforts to support parents in preparing our children to "succeed and lead by having the knowledge and skills to learn, engage civically, and lead meaningful lives."

CALL THE QUESTION made by Member Cannon and seconded by Member Boothe.

Motion to call the question carried with Members Hansen and Davis opposed.

Member Vice-chair Belanp passed the gavel to Vice-chair Davis.

Audit Committee Report

The Board requested staff seek legislation to allow the Board to determine which duties described in Subsection 63I-5-301(3) should be retained by the Board and which should be delegated to the Board's Audit Committee. Without the passage of HB 419, the audit committee was required to appoint, evaluate, and, if necessary, remove USBE's internal audit director, among other various actions. The Board was interested in retaining that authority for the Board, which is now allowed due to the amendments from HB 419.

Based on 63I-5-301(3), staff prepared a chart titled "Audit Committee Powers and Duties", which was reviewed and approved by the Audit Committee. The chart describes the duties that would remain with the Board and which duties would be delegated to the Audit Committee if Board Policy 2006 is approved. Also, an amendment to Board Bylaw VIII.3.a is needed to provide the authority to the Board to appoint, evaluate, and, if necessary, remove USBE's internal audit director.

The Committee's motion for the Board: Consistent with the request of the Board and due to the passage of 2022 HB 419, the Committee recommends the Board approve updates to Board Bylaw Article VIII.3.a and approve Board Policy 2006.

Amendments to Board Bylaw VIII.3.a and Enactment of Board Policy 2006

MOTION was made by Member Belnap that the Board approves updates to Board Bylaw Article VIII.3.a and approves Board Policy 2006 to be consistent with the request of the Board and due to the passage of 2022 HB 419.
