USDB Facilities Plan

MOTION was made by Member Lear and seconded by Member Moss that the Board approve 1) the Utah Schools for the Deaf and the Blind facilities plan and requests that the Utah Legislature's Public Education Appropriations (PEA) committee at their August 8, 2023, meeting recommend that the Executive Appropriations (EAC) committee authorize the utilization of the funds for the Salt Lake City Campus during their September 2023 meeting, and:

2) requests that the Executive Appropriations Committee of the Utah Legislature authorize the Division of Facilities and Construction Management (DFCM) to work with the Utah Schools for the Deaf and the Blind and proceed with the programming and design of the Salt Lake City Campus immediately and design of the Salt Lake City Campus immediately and continue to work on the long-term master plan for Utah Schools for the Deaf and the Blind facilities.

MOTION was made by Member Davis that the Board supports the Special Education Funding for LEAs for the 2024 Legislative Session.

The motion carried with Members Boggess, Cline, and Hymas opposed.

MOTION was made by Member Strate that the Board supports Reduce Curricular and Co-curricular Fees for the 2024 Legislative Session.

The motion failed with Members Boothe and Strate in favor.



MOTION was made by Member Boothe that the Board supports the Pupil Transportation for the 2024 Legislative Session.

The motion passed unanimously.

5. Platform to Support Implementation of Sensitive Instructional Materials (Moss, Strate, and Cline)

6. Utah Code 53G-10-503 Driver education funding: Increase funding into the LEA's operating accounts. (Hart, Lear, and Strate)

7. Adobe Create Utah (Boothe, Norton, and Moss)

8. Computer Science Integration (Moss, Wood, and Boothe)

9. Professional Outreach Programs in the Schools – Increase (Boothe, Hymas, and Strate)

10. USIMAC On-Going Funding (Wood, Strate, and Earl)

11. Benefits for USDB Paraeducators (Wood, Boggess, and Boothe)



Additional Board Direction for Legislative Funding Requests

MOTION was made by Member Davis and seconded by Member Strate that the Board direct staff to develop a legislative funding request for the 2024 legislative session to request \$11M for the Educator Salary Adjustment and request a policy change for formula adjustment.

The motion carried with Member Cline opposed.

MOTION was made by Member Hymas and seconded by Member Earl that the Board direct staff to develop a legislative funding request for the 2024 legislative session to request to add charter schools to the statewide average of what districts receive in State transportation dollars.

The motion passed unanimously.

MOTION TO AMEND was made by Member Davis and seconded by Member Wood that the Board request for charter schools be amended to include school district students who currently do not qualify for transportation funding.

The motion passed unanimously.
