#### Utah Schools for the Deaf and the Blind

Utah Deafblind Projects Application to OSEP

Susan Patten, Associate Superintendent of the Blind, discussed the project's application. To seek approval from the Utah State Board of Education (USBE) of the Utah Deafblind Project's application to OSEP's Application for New Awards; State Technical Assistance Projects to Improve Services and Results for Deafblind Children (Assistance Listing Number/CFDA 84.326).

The proposed Utah Deafblind Project intends to build the capacity of state and local agencies, parents, and service providers to improve services and results for children who are deafblind by providing high-quality, relevant, and helpful TA and information dissemination.

Proposed Annual Award from OSEP: \$99,402

Funding period: October 1, 2023 - September 30, 2028

Application deadline: February 17, 2023

## Update on USB Intensive Services

Associate Superintendent of the Blind Susan Patten provided an overview of the USB intensive Services.

- Supplemental instruction, not duplicative or replacing instruction a student is receiving.
- Modeled after other successful programs at schools for the blind (TSBVI, Washington School for the Blind, Kansas School for the Blind) and prior programs from USB (short-term intensives on campus).
- Past programs from USB have been considered short-term programs (2-5 days on the Ogden campus).

  - o Math Support Program
