### **Opening Business**

Vice Chair Hart called the meeting to order and roll call at 2:05.

### **Study Session**

### **USBE Strategic Plan Mission and Vision**

Purpose of Today's Session:

Set the stage and create a framework for Board to Move forward on updating USBE Strategic Plan – Mission and Vision.

# Purpose of a Strategic Plan:

- Unites Board around proactive efforts by orienting policy toward outcomes
- Prioritizes Resources
- Focuses on the work of the agency

Board members shared their initial feedback, which was their thoughtful and candid insights on the future of education in Utah over the next five years. Their written input from the April, May, and June 2023 meetings was captured in a separate document. The Board will address the issues raised by Board members as they move through the strategic planning process.

In preparation for the June board meeting study session, they will examine the USBE vision and mission. They will discuss the mission's and vision's purpose and how they relate to the Strategic Plan (slides nos. 9-11). They will also review the Office of Legislator General's Audit on USBE Internal Governance (attached), especially pages 13-20, which relate to USBE's

mission and vision, and pages 21-22, which address the alignment of measures of success with the goals and strategies outlined in the Strategic Plan.

Board Member Cline's comments were: "I would love to put my vision forward, or even support some of these other's with their nice sounding verbiage, but even with the best language and ideas put forward, they will do little to no good at fixing the underlying problems of our public education system, namely, the systemic sectarian control that has taken hold of our schools. This has happened despite Utah's constitution explicitly prohibiting sectarian control, not just over our K-12 public education system, but also Utah's higher education system. I have documented this siege on our system. And have the evidence to back up my claims. Until we can address the sectarian capture of our public education system, any language we put forth will simply be crosswalked to mean what the bureaucracy needs it to mean so that they can continue to "implement with fidelity," the very dogmas that are destroying public education."

**MOTION** was made by Member Earl and seconded by Member Boggess that the Board approves the recommended mission and vision statement.

**MOTION TO DIVIDE** was made by Member Boggess and seconded by Member Green The motion passed unanimously.

**MOTION TO POSTPONE** the Vision statement and approve and approve the Mission was made by Member Davis and seconded by Member Hymas.

The motion to postpone carried with Members Boothe, Davis, Earl, Hart, Hymas, Kerry, Lear, Norton, Reale, Strate, Wood, and Moss in favor and Members Boggess, Cline, and Green opposed.

The motion carried with Members Boothe, Cline, Davis, Earl, Hart, Hymas, Kerry, Lear, Norton, Reale, Strate, Wood, and Moss in favor and Members Boggess and Green opposed.
