INFORMATION: Strategic Plan Review and Revision

Purpose of Today's Session:

Set the stage and create a framework for the Board to Move forward on updating the USBE strategic plan.

Purpose of a Strategic Plan:

- Unites Board around proactive efforts by orienting policy toward outcomes
- Prioritizes Resources
- Focuses on the work of the agency

Board members shared their initial feedback, which was your thoughtful and candid insights on the future of education in Utah over the next five years. Their written input from the April and May meetings has been captured in a separate document. The Board will address the issues raised by Board members as they move through the strategic planning process.

In preparation for the May board meeting study session, they will examine the USBE



vision and mission. They will discuss the mission's and vision's purpose and how they relate to the Strategic Plan (slides nos. 9-11). They will also review the Office of Legislator General's Audit on USBE Internal Governance (attached), especially pages 13-20, which relate to USBE's mission and vision, and pages 21-22, which address the alignment of measures of success with the goals and strategies outlined in the Strategic Plan.

Approved during the September 8, 2023, board meeting was the mission as follows: **Mission: to open doors of opportunity for all Utah children.**

- Policy

The motion failed with Members Boggess, Cline, Earl, Green, Hymas, and Wood in favor and Members Boothe, Davis, Lear, Norton, Reale, Strate, and Moss opposed.

MOTION was made by Member Earl and seconded that the Board add the following: USBE protects information systems, manages taxpayer funds, directs transparent operations, develops policy for education, and sets academic standards."

MOTION was made by Member Cline and seconded that the Board amend as follows: Strike "protects" and replace with "secures."

"USBE protects and <u>secures</u> information systems, manages taxpayer funds, directs transparent operations, develops policy for education, and sets academic standards."

The motion failed with Members Boggess, Boothe, Cline, Davis, Earl, and Green in favor and Members Hymas, Lear, Norton, Reale, Strate, Wood, and Moss opposed.

MOTION was made by Member Cline and seconded that the Board amend as follows: To take "sets academic standards" and place it after "USBE."

The motion passed unanimously.

MOTION was made by Member Cline and seconded that the Board adds "and control" after "manages" and strike "taxpayer" and replace "public education."
