1 **R277. Education, Administration.**

2 **R277-630. Child Sex Abuse and Human Trafficking Prevention Training and**
3 **Instruction.**

4 **R277-630-1. Authority and Purpose.**

5 (1) This rule is authorized by:

6 (a) Utah Constitution Article X, Section 3, which vests general control and
7 supervision over public education in the Board;

8 (b) Section 53E-3-401(4), which allows the Board to make rules to execute the
9 Board's duties and responsibilities under the Utah Constitution and state law; and

10 (c) Section 53G-9-207, which requires the Board to approve, in partnership with
11 the Department of Human Services, age-appropriate instructional materials for the child
12 sex abuse and human trafficking prevention training and instruction.

13 (2) The purpose of this rule is to provide the process for a third-party provider of
14 instructional materials for the child sex abuse and human trafficking prevention training
15 and instruction to be approved for use by an LEA.

17 **R277-630-2. Application Process and Criteria.**

18 (1) A third-party provider offering child sex abuse or human trafficking training or
19 instruction shall apply to the Superintendent and be approved by the Board prior to
20 being utilized by an LEA.

21 (2) An LEA may only use a third-party provider instructional materials that have
22 been approved by the Board.

23 (3) A third-party provider shall apply according to the form and deadlines
24 established by the Superintendent and include the following within the application
25 submission:

27 ~~third party's materials or trainings align;~~

- 29 (i) 53G-9-207; and
- 30 (ii) 53G-10-402;
- 31 (b) an assurance that the materials and trainings are vetted and do not lead to
- 32 the accessibility of materials or resources that violate Section 53G-10-103;
- 33 (c) a copy of all materials to be used for instruction or training purposes and
- 34 notation for each regarding the intended audience;
- 35 (d) a list of evidence-based research that has been used to inform the materials
- 36 or training; and
- 37 (e) additional information as requested by the Superintendent.
- 38 (4) The Superintendent, in partnership with the Department of Health and Human
- 39 Services, shall establish a review committee to determine a potential third-party
- 40 provider’s advancement to the Board for final approval.
- 41 (5) The review committee members shall sign a non-disclosure agreement
- 42 regarding the materials provided ~~by a third party provider and refrain from sharing the~~
- 43 ~~materials provided with any member of the public outside of the review committee.~~
- 44 (6) The review committee shall use a scoring rubric to assess several key
- 45 program components including:
- 46 (a) training expectations, including:
- 47 (i) familiarity with state and federal law including Subsection 80-4A-201(1);
- 48 (ii) specialized instruction that considers cultural differences and needs of
- 49 specialized populations;
- 50 (iii) how to adapt instruction to be age appropriate; and
- 51 (iv) a general understanding of child sex abuse and human trafficking, including
- 52 human trafficking as a form of abuse;
- 53 (b) required program concepts, including:
- 54 (i) human trafficking definition aligned with state law;
- 55 (ii) sex trafficking definition;
- 56 (iii) labor trafficking definition;

- 76 _____ (7) A third-party provider that is sent to the Board for final approval shall make all
- 77 application materials available to the Board for review ~~and Board members shall be~~
- 78 bound to keep the materials confidential;
- 79 _____ (8) If the Board denies an application for approval, the Board shall notify the
- 80 third-party provider within 30 days of the Board's determination the reason for the
- 81 denial.
- 82 _____ (9) A third-party provider that has been denied may reapply for approval if the
- 83 reasons for the denial have been shown by the third-party provider to be remediated.
- 84 _____ (10) An approved third-party provider shall reapply for approval ~~of materials or~~
