- 74 ~~—— (1) A licensed educator who is arrested, cited or charged with the following alleged~~
75 ~~offenses shall report the arrest, citation, or charge within 48 hours or as soon as possible~~
76 ~~to the licensed educator's district superintendent, charter school director or designee:~~
77 ~~—— (a) any matters involving an alleged sex offense;~~
78 ~~—— (b) any matters involving an alleged drug-related offense;~~
79 ~~—— (c) any matters involving an alleged alcohol-related offense;~~
80 ~~—— (d) any matters involving an alleged offense against the person under Title 76,~~
81 ~~Chapter 5, Offenses Against the Person;~~
82 ~~—— (e) any matters involving an alleged felony offense under Title 76, Chapter 6,~~
83 ~~Offenses Against Property;~~

92 offense information received from a licensed educator to the Superintendent within 48
93 hours of receipt of information from a licensed educator.
94 ———(4) The Superintendent shall develop an electronic reporting process on the Board's

96 ———(5) A licensed educator shall report for work following an arrest and provide notice
97 to the licensed educator's employer unless directed not to report for work by the employer,

106 monitoring through registration with the systems described in Section 53G-11-404 as a
107 condition of employment or appointment; and
108 ———(b) identification of the appropriate privacy risk mitigation strategy that will be used
109 to ensure that the LEA only receives notifications for individuals with whom the LEA
110 maintains an authorizing relationship.
111 ———(2) An LEA policy shall describe the background check process necessary based
112 on the individual's duties.

~~———— (3) An LEA's policy described in Subsection (1) shall include the following minimum components:~~

176 public education employee shall review the arrest information and assess the employment
177 status consistent with Section 53E-6-604, Rule R277-515, and the LEA's policy:

179 licensed public education employee, volunteer, or charter school board member shall
180 review the arrest information and assess the individual's employment or appointment

193 ———(1)(a) An educator who has reasonable cause to believe that a student may have
194 been physically or sexually abused by a school's employee shall immediately report that
195 belief to:

196 ———(i) law enforcement;

197 ~~—— (ii) the school principal; and~~
198 ~~—— (iii) to any other entity to which a report is required by law.~~
199 ~~—— (b) A school administrator who receives a report described in Subsection (1)(a) shall~~
