8 ~~in order for educators to retain Utah licensure, and Subsection 53E-3-401(4) which permits~~
9 ~~the Board to adopt rules in accordance with its responsibilities.~~

10 ~~—— B. The purpose of this rule is to provide definitions and requirements for an educator~~
11 ~~to renew a Utah educator license. This rule requires verification of employment,~~
12 ~~development of a professional learning plan, and documentation of activities consistent~~
13 ~~with Title 53E, Chapter 6, Education Professional Licensure.~~

14 ~~R277-500-2. Definitions.~~

15 ~~—— A. "Acceptable alternative professional learning activity" means an activity that may~~
16 ~~not fall within a specific category under R277-500-5 but is consistent with this rule.~~

17 ~~—— B. "Accredited" means a teacher preparation program accredited by the National~~
18 ~~Council for Accreditation of Teacher Education (NCATE), the Teacher Education~~
19 ~~Accreditation Council (TEAC), or the Council for the Accreditation of Educator Preparation~~
20 ~~(CAEP).~~

21 ~~—— C. "Accredited school," for purposes of this rule, means a public or private school~~
22 ~~that has met standards considered to be essential for the operation of a quality school~~
23 ~~program and has received formal approval by the Northwest Accreditation Commission.~~

24 ~~—— D. "Active educator," for purposes of this rule, means an individual holding a valid~~
25 ~~license issued by the Board who is employed by a Utah public LEA, accredited private~~
26 ~~school, or USOE, or who was employed by a Utah public LEA or accredited private school~~
27 ~~in a role covered by the license for at least three years in the individual's renewal period.~~

93 ——— S. "License renewal points" means the points accumulated by a Utah license holder
94 through activities approved under this rule for the purpose of satisfying requirements of
95 Section 53E-6-201.

96 ——— T. "National Board Certification" means the successful completion of the National
97 Board for Professional Teaching Standards (NBTPS) process, a three-year process, that
98 may include:

99 ——— (1) national content-area assessment;

102 ——— U. "Professional growth plan" means a plan created and reviewed annually by an
103 active educator and the educator's direct supervisor that details the professional goals of

106 evaluation required under Section 53G-11-504.

355 ~~——A(1) The Superintendent shall require a licensed educator or license applicant to~~
356 ~~submit to a fingerprint background check and ongoing monitoring by the Superintendent~~
357 ~~through registration with the systems described in Section 53G-11-404 as a condition of~~
358 ~~licensure in Utah.~~

359 ~~——(2) A licensed educator shall submit a new fingerprint background check for ongoing~~
360 ~~monitoring within one calendar year prior to the date of the educator's next license renewal~~
361 ~~after July 1, 2015.~~
