3 **R277-475-1. Authority and Purpose.**

4 (1) This rule is authorized by:

5 (a) the Utah Constitution Article X, Section 3 which vests general control and
6 supervision of the public school system under the Board;

7 (b) Subsection 53E-3-401(4) which allows the Board to adopt rules in accordance
8 with its responsibilities; and

9 (c) Section 53G-10-304 which directs the Board to provide a rule for a program of
10 instruction within the public schools relating to the flag of the United States.

11 (2) The purpose of this rule is to provide direction for patriotic, civic and
12 character education programs in an LEA.

40 (1) An LEA shall provide instruction for patriotic, civic and character
41 education in the social studies curricula of kindergarten through grade twelve.

42 (2) [All educators] An LEA shall ensure an educator [shall have] has responsibility
43 for patriotic, civic and character education taught in an integrated school curriculum and
44 in the regular course of school work.

46 **R277-475-4. School Responsibilities and Required Instruction.**

47 [A.](1) An LEA shall:

48 (a) ensure that all p[P]atriotic, civic and character education programs [shall
49 meet] are consistent with the requirements of Sections 53G-10-302, 53G-10-304, and
50 53G-10-204;[-.

51 ~~—— B. An LEA shall teach students the history of the flag, etiquette, customs~~
52 ~~pertaining to the display and use of the flag, and other patriotic exercises consistent with~~
53 ~~Subsection 53G-10-304(2).~~

54 ~~—— C. The school shall] _____ (b) provide the setting and opportunities to teach [by~~
55 ~~example and role modeling] patriotic values associated with the flag of the United States~~

83 ~~A. An LEA shall provide Education about the flag and the Pledge of Allegiance to~~
84 ~~the Flag shall be taught and modeled following the plan of the social studies Core~~
85 ~~Curriculum in grades kindergarten through six.~~

86 ~~B. The Pledge of Allegiance to the Flag shall be recited by students at the~~
87 ~~beginning of each school day in each public school classroom in the state, consistent~~
88 ~~with Subsection 53G-10-304(3).~~

89 ~~C. At least once a year students shall be instructed that:~~

90 ~~—— (1) participation in the Pledge of Allegiance is voluntary and not compulsory;~~

91 ~~—— (2) it is acceptable for an individual to choose not to participate in the Pledge of~~
92 ~~Allegiance for religious or other reasons; and~~

93 ~~—— (3) students should show respect for individuals who participate and individuals~~
94 ~~who choose not to participate.~~

100 ~~[A.](1) An LEA shall adequately notify students and parents of lawful exemptions~~
101 ~~to the requirement to participate in reciting the Pledge of Allegiance.~~

102 ~~[B.](2) An [school] LEA may require an annual written request from a student's~~
103 ~~parent [or legal guardian] if a student or the student's parent [or legal guardian] requests~~
104 ~~that the student be excused from reciting the Pledge of Allegiance.~~

107 ~~A. A public school shall display IN GOD WE TRUST, the national motto of the~~
108 ~~United States, in one or more prominent places in each school building, consistent with~~

111 ~~curriculum and in the regular course of school work.~~

112 ~~—— C. Instruction in United States history and government shall be taught consistent~~
113 ~~with the Utah social studies core curriculum and Section 53G-10-302.~~

114 ~~D. An LEA shall make information about the flag, respect for the flag and civility~~
