

### CACTUS Educator Categories – 4/19/2016

*The following terms are USOE operational definitions of educator categories and subcategories in terms of the individual's assignment or assignments in CACTUS. The only assignment codes valid for educators and not included in these categories are: 24-08-00-00-001 Fellowship-Sabbatical and 24-08-00-00-080 Military Leave.*

<b>Guidance Counselors</b>	Licensed educators who provide career, school and personal guidance to students. This work occurs in classrooms, small groups and one-on-one. <b>LEA Administrators</b>	Local Education Agency or LEA is a term used in Board rule and federal regulations. These positions generally require an Administrative/Supervisory area of concentration and involve the management and leadership of multiple schools/programs. <b>Librarians and Media Specialists</b>	Most Utah librarians or media specialists are paraprofessionals; however, some districts utilize licensed media specialists. <b>Preschool Teachers</b>	Licensed educators who have early childhood degrees and work specifically with students in preschool settings. Preschools are often housed in schools serving high numbers of students who live in poverty or schools who house specific special education programs. <b>School Administrators</b>	Licensed educators, which hold an Administrative/Supervisory area of concentration, who serve as formal leaders at each school site. Duties include items such as school safety, budget, building operations and maintenance, teacher quality, student achievement, parent and community relations, core instruction, and extracurricular activities. <b>School Based Specialists</b>	Licensed educators who provide specialized support for students and teachers (i.e. Reading Specialists, Math Specialists) assigned to a school setting. Educators in this category can serve multiple schools, but have a high frequency of interaction with students. <b>Special Education Teachers</b>	This is a subgroup of regular classroom teachers who work with students identified under Individuals with Disabilities Education Act (IDEA). Typically, special education teachers are assigned a smaller ratio of students but work in regular classrooms as well as small group and one-on-one instruction. While special education teachers spend the bulk of their day instructing students with disabilities, they also have significant paperwork and assessment responsibilities per federal law [IDEA]. <b>Student Support Services</b>	Licensed Educators who provide highly specialized services that are essential to the success of certain students in the educational environment. This includes audiologists, school psychologists, school social workers, and speech-language pathologists. ## Appendix A – Definitions

**Audiologist** – Licensed educators who work in small groups and one-on-one with deaf and hard of hearing students to support achievement in the classroom. Audiologists have highly specialized skill sets that include conducting student hearing assessments and teaching techniques to augment achievement of deaf and hard of hearing students.

**Intern** – Any assignment in CACTUS can be indicated as an intern assignment. Typically, educators listed as interns have a class assignment consistent with the definition of a regular classroom teacher but they haven't completed their university preparation program. Typically, an intern assignment is a paid teaching position (typically .58) for a full year and the internship takes the place of student teaching.

**School Psychologist** – Licensed educators who work in small groups and one-on-one with students to assess, provide recommendations for interventions, or provide tutoring in appropriate social behaviors. The students working with psychologists are likely being recommended for services or have individualized education plans (IEP) in accordance with IDEA.

**School Social Worker** – These are licensed educators with social work degrees, who work hand in hand with a school's special services team, to assist children and their families with school success. Their work includes group instruction on appropriate social skills, conducting home visits, and providing direct assistance to students and their parents. They are the district's or school's liaison to the community, especially focused around health and human services needs.

**Speech-Language Pathologist** - Licensed educators who work in small groups and one-on-one with students to assist in acquisition of language skills and remedy speech impediments. Services from speech pathologists are required under IDEA, if the child's disability demands such help.
