<p>#1 Nationwide Mealtime Waiver: Support SFAs to provide access to nutritious meals while minimizing potential exposure to the novel coronavirus. Applies to NSBP, NSLP, CACFP, SFSP. Applies to NSBP, NSLP, CACFP, SFSP, SSO. FNS also issued guidance on meal delivery using existing authorities in summer meal programs. (Guidance for States on Non-Congregate Feeding Nationwide Waivers)</p> <p>*Note: One meal and a snack, or a breakfast and lunch can be offered under SSO or SFSP. <p>#5 Nationwide Parent/Guardian Meal Pickup Waiver: SFAs approved for non-congregate feeding can be approved to distribute meals to parents and guardians to take home for their children, as long as they protect accountability and integrity of the program. Applies to NSBP, NSLP, SSO, CACFP, SFSP. This also applies to guardians picking up meals for adult participants in CACFP Adult Day Care Programs.
