Disclaimer:

Indirect cost rates are based on the requirement of the *Code of Federal Regulations* (CFR) under Office of Management and Budget (OMB) grant guidance under 2 CFR Part 200, "*Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards*" (Uniform Guidance) and *Education Department General Administrative Regulations* (EDGAR) under 34 CFR Part 75 and 34 CFR Part 76.

In accordance with OMB Uniform Guidance § Subpart E and EDGAR § 76.560(b), LEAs must have an approved indirect cost rate in order to recovery any indirect costs related to federal grants and contracts.

Indirect cost rates will be based on the predetermined fixed rates with carry-forward provisions and utilize the Modified Total Direct Costs Base (MTDC) meaning all direct salaries and wages, applicable fringe benefits, materials and supplies, services, travel, and up to the first \$50,000 of each subaward (regardless of the period of performance). MTDC excludes equipment, capital expenditures, charges for patient care, rental costs tuition remission, scholarships and fellowships, participant support costs, and the portion of each suaward in excess of \$50,000.

When applying a rate to a grant or contract, the approve rate in effect at the time the allowable costs are incurred determines the amount of the indirect costs that may be charged to the grant or contract. Costs must be allowable, necessary and reasonable (see 2 CFR 200.403) and must be applied consistently from grant to grant.

Any discrepancy between this Indirect Cost Type Schedule and grant award, Statute, or Board Rule shall be resolved in favor of the terms of the grant award, Statute, or Board Rule.
