

Education Bills by the Numbers









Notable Education Bills

HB 46

Educator Modifications

Modifies the public education code regarding educator licensing to allow the Board to establish licensing requirements in rule, including the establishment of associate, professional and LEA-specific licenses.

HB 264

Elementary School Counselor Program

Authorizes the Board to award grants to local education agencies to provide targeted school-based mental health supports in elementary schools.

SB 194



Early Literacy Program

Renames the K-3
Reading Improvement
Program; amends
requirements for
participation. Requires
the Board to provide
support to LEAs failing
to meet their goals.

HB 317



Special Education Amendments

Extends an eligible student's entitlement for a free, appropriate public education for students who turn 22 during a school year until the end of the school year.

HB 286

Reproductive Ed Amendments

Modifies instruction in health to include instruction in the harmful effects of pornography and refusal skills; amends definitions for required parental consent.



Notable Education Bills

HB 132

Juvenile Justice Modifications

Clarifies the duties and allowed responsibilities of school resource officers and for two years allows LEAs to refer certain students who have committed lower level discipline offenses to law enforcement or court.

HB 233



Teacher Salary Supplement Revisions

Provides a salary supplement of \$4,100 to a teacher who has a degree in special education and is assigned to teach special education.

HB 293



Tax Rebalancing Revisions

Amends the calculation of the basic levy for a 5-year period, resulting in an increase in revenue for schools, and establishes the weighted pupil unit value and equity pupil tax rates.


Our Schools Now Compromise


