


Voted and Board Local Levy Programs Increase



Enhanced Kindergarten Amendments

H.B. 99: Senator Lyle Hillyard Representative V. Lowry Snow



Received **\$10 Million** ongoing to <u>increase access</u> to Optional Enhanced Kindergarten (OEK) for students.

Combined with the **\$7.5 million** ongoing currently appropriated for the enhanced kindergarten early intervention program, this funding will enable early intervention for about **25**% of students starting school unprepared for kindergarten.



The **\$2.88 million** in TANF funds supporting the Kindergarten Supplemental Enrichment Program are expiring at the end of the 2019-2020 school year. This termination of funds affects programs in **46** schools across **17** LEAs.

Current nationwide and statewide data show better outcomes for students who are enrolled in full-day kindergarten.

Research demonstrates that students who attend quality early-childhood programs like kindergarten are more likely to go on to college, earn more, and save for retirement as adults.



Grants allow funding to flow through to LEAs down to schools where the student needs are highest. The funding is most often used for the salaries and benefits of kindergarten teachers.

The funding gives LEAs the ability to extend kindergarten instruction from a half-day of instruction up to a full day of instruction.



About 40% of Utah students are coming to kindergarten at risk for academic failure; only half are being served through extended learning experiences.



Only 24% of Utah children have access to state-funded OEK compared to 80% nationally.

Early Learning Training and Assessments

H.B. 114: Senator Ann Millner Representative Steve Waldrip



To provide targeted professional learning and ongoing, job-embedded coaching to support preschool through grade three teachers in their instructional practice and to improve student outcomes in literacy and mathematics.

To establish a science of reading assessment for teacher candidates to ensure basic foundational knowledge of teaching reading.



Teachers matter more to student achievement than any other aspect of schooling. Many factors contribute to a student's academic performance, including individual characteristics, family, and neighborhood experiences. But research suggests that, among school-related factors, teachers matter most.

A teacher is estimated to have **two to three times** the impact of any other school factor.

Why not add these funds to the WPU?

Utah is prioritizing and aligning efforts in the early learning space. LEAs will have access to common resources and evidence-based strategies with support from USBE and a statewide network.



Through professional learning, followed up by job-embedded coaching or other supports, preschool through grade three teachers will advance their knowledge and skills in the science of reading and mathematics. LEAs will identify schools and grades that demonstrate a need for improved learning outcomes and provide targeted professional learning and follow-up to support teachers in advancing their students' learning.



About half of Utah students are not proficient in English Language Arts (ELA)and mathematics by third grade.



In 2010, \$77 million in professional learning funds were repealed at the state legislature, and had not been replaced.



Kindergarten students in schools that fully implemented the professional learning and job-embedded coaching model experienced 2x the number of students achieving typical or better growth than their school district peers and over 4x the growth of their state peers.



School Leadership Development Amendments

S.B. 99: Senator Ann Millner Representative Val Peterson



Builds upon State Board approved recommendations from a statewide working group and is aligned with the agency's strategic goal for Effective Educators and Leaders.

Creates a Transformational Principal development grant program.

Adds a School Leadership Specialist role to develop and execute a performance assessment and the Transformational Principal development grant program.

In most Utah LEAs, current school leaders lack access to robust professional learning and a network of colleagues to discuss problems of practice due to lack of resources.

Effective school leaders are important.

School leadership is second to teaching in school-related factors that positively impact student learning.

Principals strongly shape the conditions for high-quality teaching.

Principals are the prime factor in determining if teachers stay in high-needs schools.

The success of all school reform approaches depends on motivations and capacities of local leadership.

Effective school leaders can impact teachers and students.

Research across the decades has confirmed that effective school leadership is associated with better outcomes for students and schools. A high-quality school leader affects dozens of teachers and hundreds or thousands of students. Principals provide a pivotal role in our schools.

School leadership can be developed.

Recent research suggests that implementation of leadership standards, principal pre-service preparation, and principal on-the-job induction, mentoring, coaching, evaluation, and supports benefit students and schools, can be implemented in different ways, and are affordable.

In a 2018 survey of Utah school administrators



School Leadership Development

Utah is a diverse state. Our districts and charter schools have different needs and priorities around the development of school leadership. The school leadership grant program has been designed to support all districts and charter schools in their role as the key lever for influencing the quality of school leadership. Features of the grant program include:



School leadership development grants (\$4,800,000):


- Improve the principal pipeline for all schools
- Provide meaningful job-embedded experiences to school leader candidates
- Provide three years of high quality mentorship for every new school leader
- Support principal supervisors; ensure cycle of improvement for all school leaders



- Will develop/execute a school leadership performance assessment, and the Transformational Principal development grant.

School Leadership Timeline

Multiple stakeholders have been involved in the development of this recommendation including, policy makers, school leaders, teachers, representatives from higher education, and parents.



2020 Notable Education Bills

The following are notable bills which passed during the 2020 General Session.

H.B. 242

Charter School Operations and School Accounting Amendments

Amends certain provisions related to school accounting methods, and the approval, oversight, and closure of charter schools by an authorizer.

S.B. 119

School Accountability Amendments

Removes requirement for the USBE to assign each school an overall letter grade for the 2018-2019 and 2019-2020 school years.

H.B. 58

Electronic Cigarettes in Schools Amendments

Requires policies for electronic cigarettes and school plans to address the causes of student substance use. Requires schools to develop positive behavior plans, and expands prevention programs to students in grade 4 or 5.

H.B. 384

Juvenile Justice Amendments

Allows schools to refer a minor for a class C misdemeanor committed on school property, or for being truant if the minor refuses to participate in an evidence-based intervention and prevention, and intervention provided by DJJS.

H.B. 323

School Mental Health Funding Amendments

Establishes a grant program for LEAs to conduct mental health screenings for students and allows LEAs to use TSSA money to match money for school-based student support. H.B. 67

LEA Financial Information Systems

Provides funding to support LEAs in meeting the required capabilities established by USBE for an LEA financial information system. H.B. 222

Start Smart Utah Breakfast Program

Requires schools that participate in lunch to enroll in school breakfast unless granted a waiver. Schools with certain percentages of students qualifying for free or reduced lunch must use an alternative breakfast model.

H.B.

School Absenteeism and Truancy Amendments

Clarifies definitions around absence and truancy, limits the conditions under which an LEA can penalize a child for truancy, and adjusts requirements for LEA annual reporting on absences.

H.B. 391

School Textbook Fee Amendments

Amends the definition of textbook to exclude instructional materials/supplies, defines what an instructional material and supply includes, and allows LEAs to continue to charge fees for those materials and supplies.

S.B. 79

Regional Education Service Agencies

Renames regional service centers an regional education service agencies (RESA), provides additional duties and authority, including allowing a RESA to apply directly to USBE on behalf of member LEAs.

S.B. 166

Student Data Privacy Amendments

Extends deadline to July 2023, for LEAs to submit data for school disciplinary and law enforcement action report. Eliminates requirements to include suspension and expulsion information on a student's transcript.

Special Needs Scholarship Amendments

Creates the Special Needs Scholarship Program, for students to enroll in private schools or pay for other qualifying expenses. Allows private donors to donate to a scholarship granting organization for a tax credit.
