## Changes Effective SY 2026-27





Each LEA awarding graduation credits must ensure that every school offers <u>at least one option</u> for each graduation requirement that:

Fulfills the graduation requirement

Does not require any fee or waiver

Exclusions: This does not apply to charter schools only offering one of the following for a graduation requirement:

AP, IB, concurrent enrollment (Section 53E-10-302)



Any fees for activities, courses, or programs must be clearly identified alongside their descriptions in the LEA's registration materials.



## An LEA may only charge a fee that:





Directly benefits the student paying the fee, not general in nature.



Directly related to the LEA's expense for the specific activity, course, or program.



Equal to or less than the incurred expense.



Does not replace or subsidize a prohibited fee, including normal instructional costs.



## Changes Effective SY 2025-26

May <u>not</u> charge a secondary student a fee for: an expense related to a non-fee course *(except as provided in subsection 2B)* 

a textbook (except for AP, IB or CE)

school equipment

a common education expense

## **Discretionary Projects**



**Option for Secondary Students:** May request a discretionary project instead of the required one.



Key Requirement: Discretionary project must show the same core skills.



Additional Projects Allowed: Students can do extra projects besides required ones.



**Fees:** The LEA may charge for materials or fees for discretionary or extra projects, including requiring students to bring their own materials.



**No Guarantee of Approval:** Requesting a discretionary project doesn't mean it will be approved.



## **Elementary School**

#### An LEA may not charge a fee for:

- Elementary school activities during the regular school day.
- Supplies used by students during the regular school day.

Teachers may provide parents with a voluntary supply list. Lists **must** include the following language before identifying the supplies:



NOTICE: THE ITEMS ON THIS LIST WILL BE USED DURING THE REGULAR SCHOOL DAY. THEY MAY BE BROUGHT FROM HOME ON A VOLUNTARY BASIS, OTHERWISE, THEY WILL BE FURNISHED BY THE SCHOOL."



## Annual Board Approval R277-407-6(2)(a)

**Approval Date Deadlines Extended:** 

**SY 2025-26:** The approval deadline has been extended from April 1st to July 1st.

**SY 2026-27 - Ongoing:** The approval deadline has been modified from July 1st to June 1st.

Applies to: Fee schedule and Fee Policies





## Fee Structure for Scholarship Student Expense R277-407-7



An LEA offering classes, programs, or services to scholarship students with expenses beyond tuition must establish a transparent and fair fee structure.

An LEA may establish the required fee structure without adhering to R277-407-1 through R277-407-6.

Fee Schedule should:	Be based on actual costs of the services or items covered	
	Match the fees charged to enrolled students for the same services or items	
	Itemize all charges and fees	
		Explain the basis for each fee
	Be updated annually	



### Change to Fee Waiver Accounting and Rule R277-113-8. LEA Accounting Requirements.

(1)(f) Each LEA shall [beginning with the fiscal year that begins on July 1, 2021, accrue school fees, and fee waivers and use contra revenue accounts to record fee waivers in the LEA's accounting system] ensure that fee and fee waiver accounting aligns with GASB34.

# **Monitoring** 53G-7-503 (8)

(8) Notwithstanding Section 53E-3-401, if the state board finds that an LEA has violated a provision of this part, the state board shall impose corrective action against the LEA, including:

- (a) requiring an LEA to repay improperly charged fees;(b) withholding state funds; or
- (c) suspending the LEA's authority to charge fees for an amount of time specified by the state board.

## Fees for Textbooks 53G-7-501(14) & R277-407-11



LEAs may <u>NOT</u> charge a fee for textbooks except for concurrent enrollment, IB, or AP courses. Fees are subject to fee waivers.



Textbooks include:

hardcopy books or printed pages of instructional material, including consumable workbooks computer hardware, software, or digital content

## Elementary School Supplies R277-407-3(6)



Supply lists must start with the following notice before itemizing the contents:

NOTICE: THE ITEMS ON THIS LIST ARE MEANT FOR USE DURING THE REGULAR SCHOOL DAY. THEY CAN BE BROUGHT FROM HOME ON A VOLUNTARY BASIS; IF NOT, THE SCHOOL WILL SUPPLY THEM.
