

### Who benefits from SOEP participation?

#### Students who need to:


- Graduate early
- Have flexibility for sports/activities
- Take care of siblings/family
- Prioritize medical situations/anxiety
- Take classes not offered in their rural school



### How do students register for SOEP courses?

- 1. Receive an email
- 2. Approve or Reject

### How do districts approve SOEP courses?

- District approvers have
  3 business days to
  approve course requests
- If no action is taken, the Utah State Board of Education (USBE) will accept it on their behalf



### How to check a student's progress



- Counselors should communicate with the online school
- Working closely with online schools regarding seniors is crucial
- Recent legislation is beginning the work on developing a dashboard

### Transcripts

# Online schools have 30 days to send transcripts to the school and the student's family




#### Full Course-Loads

- Summertime courses should be recorded for the fall
- If their fall schedule also is a full load, they will be "over enrolled"
- Account for this by selecting "Early Graduation" in SEATS/SIS

The "Early Graduation" tag is just to indicate over-enrollment

### Small Schools Funding



Schools with under **1,000** students AND at least 1 HS Student

SOEP course fees are fully funded by the legislature

### Students with an IEP, 504 or ML

- The student's plan must be shared with the online school.
- The online school will provide accommodations for the student.
- If the IEP or 504 plan team is meeting to make any changes, a representative from the online school should be invited.

### HB 247 (as of 2024)

- (g) annual mandatory training for relevant staff at a primary LEA that includes:
  - (i) program requirements for a primary LEA including reporting requirements and methods; Course and teacher generic codes, transcripts, CCAs registration and approval process
- (ii) uses of resources and tools to ensure adequate monitoring of an eligible student's progress; Statuses?? Dashboard preview?? Counselors should initiate communication with providers to get progress information
  - (iii) federal and state requirements for accommodating enrollments that involve special education; IEP, 504, and ML information
- (iv) appropriate circumstances and methodologies for reducing an eligible student's schedule; and Early graduation if more than 1.0 FTE, managing a student's schedule, Summer classes need a place in the schedule, so either reduce the student's schedule to fit them in or do early graduation.
- (v) other components the state board determines are necessary; and Keep a running list: Seniors, athletes, 20 day withdrawal period (look at law) & how to withdraw, attempt to complete after the 20 days.

Grade replacement is higher than a SEATS approval, R277-717, students has to have specific approval BEFORE from their counselor that the core code matches the credit increment.
